- 7. The requester assumes all responsibility for possible infringement of intellectual property right laws, including copyright, which may arise when using materials, held in the Photographic Archives.
- 8. Requests for copies of graphic items intended for single mass reproductions into formats such as posters, postcards or books, may be subject to special licensing agreements and will be evaluated on a case-by-case basis.
- 9. The requester agrees to pay the Petaluma Historical Library & Museum upon acceptance of this contract, and prior to the delivery of the reproductions, all expenses as defined in the Photographic Price Schedule.
